Extended Description: This course is designed to introduce students to the literature on civil-military relations. The issue areas that this course focuses on include theories of civilian control, coups d'état, military regimes, civil-military relations during transitions to democracy and in stable democracies, the role of the military in state formation, and Turkish military's role in politics.

- Be able to compare several dimensions of the interaction between governments and military organizations in different parts of the world.
- Understand how the study of the military is essential to answer numerous questions in domestic and international politics.

- Improve their analytical and critical thinking skills through class discussions and written assignments.
